Treasurers Report 2016

[For the year to 31 December 2016]

Income - Our accounts show that the number of allotment holders across the city is stable. Our records show 4 less than last year with 2541 members generating £1016.40 recorded as subscriptions. This enrolment is important as it links with the purchase of insurance provision.

Insurance – This is a complicated process involving more paperwork than before. It can take a long time to complete the documentation, submit it and agree a final payment before the final documents are issued. As long as your application is in on time your previous years documents are valid. Apart from this large input of voluntary time it works out as a nil cost item to O&DFAA as our payment is refunded by OCC Parks budget as agreed in our lease.

The 2016 competition was budgeted for, but the running costs were lower than anticipated so the entire cost fell within the parks budget allocation. The costs shown matched income refunded by OCC.

The sign project started two years ago with a £500 grant from OCC to develop a new allotment sign. Wendy did the design at no cost so we used this OCC grant money along with O&DFAA funds to offer every site a free site. 30 sites took up the offer of a signs. We also offered the opportunity to purchase extra signs. This was taken up by 5 associations who paid £826. 40. Since the accounts were finalised the printing bill of £2772.40 has come through. ODFAA has contributed £1446 from our funds which are made up from money paid in annual subscriptions – a payback to all sites that took the offer.

We also operated a very successful Autumn lecture event which attracted about 60 members. This was an excellent talk on soil. This was run as a 'free' event so is another payback to members /allotment holders. The cost of the speaker and hall hire was £411.50

Finally the expenses involved in administering ODFAA were £189.83. The increase is largely as a result of the amount of photocopying involved for the insurance process.
