1. Welcome and apologies.

- Meeting chaired by Wendy Skinner Smith. 37 Reps representing 28 sites and OCC Parks were thanked for attending.
- Emma Taylor (OCC) and Cllr Louise Upton have sent their apologies.

2. Minutes of the last ALM

• The minutes of ALM held 22 January 2019 had been circulated and agreed as an accurate record.

3. Lease Progress

• You should all have returned allotment survey questionnaires due last September. Several of these have still not been returned – Emma Taylor is chasing these.

• Emma is currently seeking internal Council approval for the proposed updated lease processes.

4. Oxford City Council Reactive maintenance budget 2017-2018 update

- Final out-turn unavailable as year-end was only a week or so ago. Once this is available SF will circulate to ODFAA. A1
- C. £3K left in March: used for a second round of grants. Associations who were successful were: Barns Court, Barracks Lane, Fairacres, John Garne Way, Osney St Thomas, St Clements & District.
- Agree focus for OCC Allotment Grant fund 2018-2019. ODFAA /OCC recommend we use grants this year for security, accessibility, composting and water harvesting.
- Other suggestions included: muntjac deer culling! Unlikely to be able to get this past OCC. Better to contact a pest control firm. It was reported that either lion hair or even human hair deters deer.
- Agreed to broaden definition of water harvesting to include boreholes as it is harvesting groundwater. As the cost of boreholes is expensive it is likely that OCC would only to be able to provide funds to match Association spend.
- Grants cannot be used for machinery.
- Budget will be £3,900 plus any non-spend accumulated during the year.
- OCC Grant Application forms will be issued in May latest but hopefully before Easter.



5. Zurich Insurance

- Zurich covers our employee and public liability insurance. Renewal policy came in yesterday.
- This policy is distinct from any possible insurance cover for assets e.g. Association sheds. Difficult situation as cover is available but probably useless as Associations don't actually own these assets.
- Alison Nash and Emma spoke and proposed new lease would assign all buildings and structures to ODFAA – but we don't think that would work.
- It would be better to assign these to the Associations for the duration of the lease. These would then form part of an Association's Site Asset Management Plan.
- Negotiations are ongoing. Solution needed by the time the new leases commence in 2021.

7. Report on Pennard Plants day

- Provisional booking for Pennard Plants at West Oxford Community Centre (WOCC) for Jan 5th, 2020 with similar opening but suggest 10.00am to 1.30pm hall booked for 9am-2.30pm
- ODFAA pay for venue and advertising but we get a small percentage of their sales.
- Some varieties aren't available that early but the previous year the event was later and they had sold out of some varieties.

8. Centenary plans

- 3 not quite finished versions of the Centenary Publication being circulated round the meeting.
- Oxford Grenoble link is 30 years old. Suggested a visit to Grenoble on 10th May or failing that a synchronised event e.g. a tree planting. Various suggestions for where the crabapple tree could be planted – Fairacres suggested as a possible site given their previous involvement in the Grenoble link. To be discussed offline after meeting. A3
- Centenary Day is 21st August but a weekend around National Allotment Week would be good if we could advertise that each ODFAA site is doing something around the same time. 16 expressions of interest.

- Key change **Associations have to choose their best plot in each category** to put forward and prizes are increased.
- There will be a winner and runner up prize for each of the categories.
- Entry by Associations to qualify for 'Best site' award requires a minimum entry of one plot in <u>at</u> <u>least three of the five</u> categories:

• under 35 years	• 35 to 64 years	• 65 to 75 years	• older than 75 years

- Invitations to enter to be sent out end of April. A4 Entry deadline in May 17th. Sites will be judged in both June and September (see events diary at the end of these minutes).
- October date and venue still waiting to hear from OCC as to what they might offer by way of supporting the Centenary.

- Site security a few recent issues (three break-ins). Any damage, incidents etc. Should be reported to the police using the non-emergency 111 number. ODFAA Site Security Guide on website.
- Increased number of complaints regarding bonfires on allotments Parks can't defend Associations
 if their behaviour gets Environmental Health involved. Several suggestions for how to reduce risk of
 causing a nuisance bonfires during winter not summer, while it is raining, first week of November!
- Livestock on plots. Under the law only rabbits and hens are permitted. ODFAA will pull some guidance around this issue together and put on the website.
- Further approach from Oxford Science & Ideas Festival Headington Hill park event on May 4th. Offer to use this as an opportunity to advertise allotment gardening.
- The Big Green Day Out June 8th. Free stall in Broad Street if we want it for an allotment display including Centenary. Looking for people to do a couple of hours on the stall.
