Caroline Chanides reported that OCC have strict rules on pesticides, especially regarding storage. They will share their 'banned list' with ODFAA.

They have disposed of waste for us in the past and will be able to supply the correct paperwork under the Hazardous Waste Reg 2005

The Allotments will need to gather this all up to one site and go through all the items, list the contains and packets names, whether empty or part empty, all containers and packages with any residue chemicals still in them will need to be listed with name of the main chemical within, and percent within each container or packet.

Once you have this all listed lan should be able to help you.

They charge a fee, but it is possible to get this funding through the ward councillors' budgets. **JL volunteered to investigate coordinating the collection across all sites.**
